2. Your signed statement reading as follows: "I certify that the amount of the draft is payable pursuant to Kansas solid waste regulations issued under authority of K.S.A. 65-3401 *et. seq.*"; and
3. This original Letter of Credit for endorsement and return, or for cancellation if this draft exhausts the total amount of the credit first stated above.

This Letter of Credit is effective as of \_\_\_\_\_ and shall  
expire on \_\_\_\_\_, but such expiration date shall be  
automatically extended for a period of one year on the first expiration date and on each successive  
expiration date, unless, at least 120 days before the current expiration date, as evidenced by the certified  
mail return receipts, we notify both you and the owner or operator by certified mail that we have decided  
not to extend this letter of credit beyond the current expiration date. In the event you are so notified, any  
unused portion of this Letter of Credit shall be available to you upon presentation of your sight draft during  
the 120 days period ending on the current expiration date.

Whenever this Letter of Credit is drawn on under and in compliance with the terms herein, we shall duly honor such draft upon presentation to us, which presentation may be in person or by means of a signed writing, and we shall issue the drafted funds in accordance with your instructions.
