A public hearing will be conducted at 9 a.m. Thursday, April 10, in the conference room in the offices of the Kansas Development Finance Authority, 555 S. Kansas Ave., Suite 202, Topeka, on the proposal for the Kansas Development Finance Authority to issue approximately \$8,500,000 principal amount of Housing Development Revenue Bonds for Argent Woodland Village, L.P., a Kansas Limited Partnership, or an affiliated entity (the developer). The bonds will be issued, pursuant to K.S.A. 74-8901 *et seq.*, to finance the costs of acquisition and rehabilitation of an existing 198-unit housing complex to be operated as Woodland Village Apartments and located at 2940 Ralph Bunche Drive in Leavenworth, Leavenworth County, Kansas, and related improvements and equipment to be used for public housing purposes (the project).

The bonds, when issued, will be a limited obligation of the Kansas Development Finance Authority and will not constitute a general obligation or indebtedness of the State of Kansas or any political subdivision thereof, including the Authority, nor will the bonds constitute an indebtedness for which the faith and credit and taxing powers of the State of Kansas are pledged. The bonds will be payable solely from amounts received from the developer, the obligation of which will be sufficient to pay the principal of, interest and redemption premium, if any, on the bonds when they become due.

All individuals who appear at the hearing will be given an opportunity to express their views, and all written comments previously filed with the Authority at its offices at 555 S. Kansas Ave., Suite 202, Topeka, 66603, will be considered. Additional information regarding the project may be obtained by contacting the Authority.

Background

In accordance with the Secretary of Health and Environment's goal to develop and promulgate groundwater-protection practices for sensitive groundwater areas in the state and specifically to address the Equus Beds Aquifer, KDHE is proposing to develop and promulgate regulations addressing municipal, commercial and industrial wastewater lagoon liner requirements. These regulations are intended to enhance the protection of groundwater resources in the state by addressing the design, construction and operation of wastewater lagoons that serve municipal, commercial and industrial facilities; convert current policies regarding industrial wastewater pond liners into regulations that will make them an enforceable part of the Minimum Standards of Design for Water Pollution Control Facilities-1978; update provisions of the Minimum Standards of Design for Water Pollution Control Facilities to reflect current technology and recent information regarding the effectiveness of earthen lagoons for the containment and treatment of wastewater; and provide uniformity in regard to KDHE's approach to the design, construction and use of wastewater lagoon systems serving municipal, commercial and industrial facilities.

KDHE is specifically seeking input regarding concepts, issues and concerns that the public believes should be reflected and incorporated into the proposed regulations. To that end, KDHE has prepared materials highlighting concepts and issues currently being evaluated by KDHE in an effort to help generate ideas and input from the public to be shared with KDHE. The purpose of the public meetings is to solicit that input, which will assist in generating the framework and format for the proposed regulations. KDHE will provide brief presentations at the start of the public meeting explaining the state regulation adoption process followed by a summary of regulation concepts and issues under evaluation at this time.

Upon completion of the public meetings, KDHE will summarize and evaluate the comments received and de-

velop draft regulations. The draft regulations will then be directed through the formal regulation adoption process, which will include a public notice in the Kansas Register and one or more public hearings to receive input regarding the proposed regulations.

Persons wishing to provide concepts, issues or concerns for consideration by KDHE may direct their comments to the attention of Dorothy Geisler at the e-mail or office address given above or by providing comments at the public meetings. Due to the detailed nature of the subject matter and expected significant interest in the development of the proposed regulations, it is recommended that written comments accompany any oral presentation at the public meetings. Submission of written comments at the public meetings will ensure that if time has to be limited for oral presentations because of the number of people desiring to provide input, that concepts, issues, comments and concerns will be directed to agency staff, in full detail, and also will provide a mechanism by which agency staff can contact the individual in the event agency staff seek additional information or clarification. KDHE will continue to receive written comments through the close of business April 28.

Any individual with a disability may request accommodation in order to participate in the public meetings. Requests for accommodation should be made at least five working days in advance of the meeting by contacting Dorothy Geisler.

Request for Comments

The Kansas Department of Health and Environment is soliciting comments regarding a proposed air quality operating permit and amending previously-issued construction approval. MFG Construction Products, Inc. has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et seq. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards and requirements applicable to each source; and the monitoring, record keeping and reporting requirements applicable to each source as of the effective date of permit issuance. Notice also is given that certain requirements in the construction ap-

proval dated July 12, 1995, are being modified by a modification of approval conditions.

MFG Construction Products, Inc. owns and operates a reinforced fiberglass parts manufacturing and repair facility located at 1018 W. Sycamore, Independence.

A copy of the proposed permit, permit application, all supporting documentation all information relied upon during the permit application review process, and a copy of the modification of approval conditions are available for a 30-day public review during normal business hours at the KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka; and at the KDHE Southeast District Office, 1500 W. 7th, Chanute. To obtain or review either document, contact Ann L. Spitz, (785) 291-3271, at the KDHE central office; or Lynelle Stranghoner, (620) 431-2390, at the KDHE Southeast District Office. The standard departmental cost will be assessed for any copies requested.

Direct written comments or questions regarding the documents to Ann L. Spitz, KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka, 66612-1366. In order to be considered in formulating final document decisions, written comments must be received by the close of business April 28.

A person may request a public hearing be held on the proposed documents. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Connie Carreno, Bureau of Air and Radiation, not later than the close of business April 28 in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the 30-day public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA 45-day review period. If the EPA waives its 45-day review period, the 60-day public petition period will start directly after the 30-day public comment period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period.
