(c.) The Miscellaneous Small Groups are Drug Groupings which generally contained less than 5,000 reported claims in the group. For consistency, a Drug Group not reported in one of the plans (i.e. KHHS, Medicaid, or State Employee Health) is not reported in all of the plans. The Small Groups include Anesthetics,Local; Contraceptive Cream/Foam/Device; Dental Agents; Devices & Non-Drug Items; Gold Compounds; Heavy Metal Antagonists; Immunosuppressants; Oxytocics; Pharmaceutical Aids/Adjuvants; Serums, Toxoids, Vaccines; and an Unknown Group Name category.
